In the event this application and membership in the Club is not approved by the Board of Directors, or the application is withdrawn prior to Board consideration, all deposits will be refunded and this application cancelled and of no further effect. Following approval of membership by the Board of Directors, all deposits are non-refundable.

Upon acceptance for membership in the Club, I agree to pay all dues, charges, assessments and other fees incident to such membership. I further agree to comply with, and be bound by, the Bylaws and other Rules and Regulations of the Club, as they may be amended from time to time, and to require all members of my family and my guests to do the same. I acknowledge receipt of a copy (electronic or printed) of the Bylaws and Rules & Regulations of the Club.

Types of Membership

Proprietary members are granted an ownership interest in the Club and the number of Proprietary memberships limited to 400. The initiation fee for a Proprietary membership is determined by the offering price of a selling Proprietary member. Proprietary members are entitled to vote and hold office. Dues are \$490 per month (4/1/08 through 3/31/09) and the quarterly spending minimum is \$360. Proprietary memberships are the only memberships that are transferable, subject to a transfer fee of 1/3 the selling price or \$20,000, whichever is greater.

Young Executive members have the rights of a Proprietary member except the right to vote, hold office, and hold ownership interest in the facilities or assets of the Club, and are between the ages of 21 and 39. The number of Young Executive memberships is limited to 35. The initiation fee for Young Executive members is \$5,000 with subsequent annual payments of \$1,000 which are applied toward the purchase of a Proprietary membership by or before reaching age 39. Dues are one-half (1/2) of a Proprietary member's dues and the quarterly spending minimum is the same as a Proprietary member. The initiation fee for an issue (child, grandchild) of a Proprietary member is \$2,500, with the same subsequent annual fees/payments of \$1,000.

Social members are granted the same use of the Clubhouse, Swimming Pool, and Clubhouse facilities and banquet privileges as Proprietary and Young Executive members. The initiation fee for Social Membership is \$500. Monthly dues, with golf privileges, is \$175. Monthly dues for dining, pool, and facility use is \$125. The same quarterly spending minimum charged Proprietary and Young Executive membership applies to Social members. The total number of Social memberships is limited to 150.

Corporate memberships may be Proprietary, Young Executive, or Social. A corporation may hold a membership, and that membership, and all accorded privileges, may be used by only one employee of the corporation. Monthly dues and quarterly minimum requirements are the same as for each type of membership as noted above.
